## FIRE CHIEF'S REPORT

- Chief Eisenacher reported that the Fire Company responded to 24 calls in August and 198 calls y-t-d.
- They got a Federal Grant for thermal imaging cameras.
- The work is still in progress at the Fire House for the tower that the County is putting in for this end of the County.

#### TREMONT AMBULANCE REPORT

• Scheibley reported that the Ambulance responded to 53 volunteer and 75 paid calls in July and 51 volunteer and 92 paid calls in August. 391 volunteer and 610 paid calls y-t-d.

### FEMA BRIC –DTA GRANT

We attended a virtual meeting between the Borough and the FEMA DTA Group on September 9, 2024. The next scheduled meeting between the Borough and FEMA DTA will occur virtually on September 23rd at 3:00 PM.

### DCED Grant from Commonwealth Financing Agency

On December 19, 2023, Tremont Borough has received a \$300,000.00 grant from the Commonwealth Financing Agency through the Department of Community and Economic Development. Please note, the grant application was for \$375,000.00. Therefore, the Borough will have to provide a 15 % match (\$56,250.00) plus the funding shortfall of \$18,750.00. This grant will provide funding to do the stormwater collection and conveyance projects as outlined in the Army Corp Study as well as replacing the storm pipe under Route 25.

DCED has sent the executed grant agreement electronically. I have forwarded the agreement to the Borough Secretary along with the forms to be submitted for reimbursement of costs. LHAI still needs the survey information from the Army Corp to prepare the design drawings and construction documents for the project. Please note, all funds must be spent by September 30, 2026.

#### Borough Playground

Keith Heigel is coordinating the next step in the process with DCNR. The grant will have to be managed through the new Grants Customer Service Portal. Grantees are encouraged to submit a Partial Payment Request for 50% of the grant award through the Grants Portal Payment Link. All partial payments must be deposited in a separate interest-bearing account. The design/construction plans have been submitted to DCNR for approval. We cannot proceed with the project until DCNR approves the construction plans. DCNR is still reviewing the project.

We anticipate putting the project out to bid this December; with construction occurring in the spring of 2025. Please note, all funds must be spent by December 30, 2025.

• Amanda Eisenacher is looking into possibly using a room in the Borough Building for the Boy Scouts to use. They might be able to use the TCO Room until PennDOT is done.

  - Who is responsible for line on North Street property and why doesn't it back up through the street?
  - Shenandoah's Code Officer (Mark Pronio) quit, the Mayor would like to see if he would be willing to do our Code Enforcement so we would only have Light-Heigel for property maintenance.
  - Trucks are parking on Popular Street on top of old tunnel and other places throughout the Borough. We can not have them towed because we don't have a police ID number.
  - Backlog of Q-O-L Complaints
  - Can people put No parking signs up for a vacant lot? Hobbs said that they can't stop people from parking on public streets.
  - The Mayor would like to look into a speed trap. Hobbs feels it is too risky to have him start issuing speeding tickets.
